It's available in multiple sizes, too, to suit a wide range of applications including caps and dividers in matching colors.

## Construction Progression

1. We start by taking measurements and working up a building permit package for the municipality. This may involve the acquisition of an architectural engineer's stamp which is only necessary where a particular municipality requires this. Call b4 you dig services are notified for underground locates and service personal from the utility companies may come to your home and chalk mark there underground lines such as gas and or electric and television lines to avoid cutting them and interrupting services as we dig the pier holes.
[ 3 days to 2 weeks]
2. Next we layout the piers with marking paint and then dig the holes for them for inspection by the municipality. [ 1 day]
3. After Pier depth inspection \#1, we pour the piers with cement and allow them to cure for [7 Days] other work is done but will not require crews' onsite for the entire 7 day cure time of the piers.
4. Once the piers have cured we start construction of the frame work. Throughout the framing construction process quality control inspections are done by county deck services to ensure the framing was done correctly as well as inspection \#2 is scheduled with the municipality before the decking is installed. [5 to 7 days]
5. Next we finish your project by installing the decking, safety railings, grasping handrail (if required), optional skirting /lattice and lighting as well as scheduling a final inspection with the municipality [ 5 to 10 days]

In conclusion, it can take from 20 to 45 days [ 3 to 6 weeks] to finish, constructing your project depending on the municipal requirements and or the options selected in the design. Throughout the construction process you are free to comment on anything you have questions or of concerns about. Each day we clean the debris or organize the material and supply's in order to provide a safe as possible area for the home owner as well as our employees. A field tent $10^{\prime} \times 20^{\prime}$ may be setup to provide temporary storage for tools and small material items and or shelter from rain for materials, items packaged in cardboard for example.

## Payment

County Deck is paid for labor services. The customer buys the materials directly from the retailer through a retail account, a credit account or by cash sale. In this model the cost is broken down into multiple parts listed below in order of occurrence.

1. Architectural stamped drawings : (if required by your municipally) We have a service in Saugerties ny which provides this for us. The cost is paid directly to them from you, We work with the engineers' architect to ensure the design is compatible with the project as a 3rd party interest.
2. Small Materials Expense Deposit **: This amount is determined by adding the estimated costs for items not to be purchased under a bulk material purchase. This saves money on the cost of materials, for example the cost of copper flashing at Curtis Lumber is $\$ 140.00$ for each $20^{\prime} \times 8^{\prime \prime}$ roll while the cost for a like same cooper flashing at home depot is $\$ 50.00$.
3. Bulk Materials : We set up a pruchace order at the retailer chosen acording to need availability and cost as well as the method for payment (retailer account). The customer then makes payment directly for bulk materials.
4. Labor : when you are satified the work agreed has been completed. A final statment,Invoice and credit memo are included with recipts. Any expence deposit ammounts not account for in recipts as well as any credits from returned or unsused materials is subtracted from the Labor balance.
**Note: in some instances there may be a need for additional small expence deposit capitol in such cases an accounting for the origional small expence deposit is made and the reasoning for the additional funds are discussed.

We at county deck want our customers in as much control of their investment as possable, to help our customers feel they are spending there money wisely, feel they have received quality work at a bargain price and have increased the value of their home.

As qualified professionals who contract to give our customers security and piece of mind that construction of there additional living environment is safe for them, their families and there guests, we take this responsibility to ensure this is true.
